PHONE TAPPING IN INDIA

Recently, several politicians have accused the Centre of protecting officers under probe for tapping the phones of political leaders.

Phone Tapping in India

Meaning:

It means interception of the contents of communication through a secret connection to the telephone line of one whose conversations are to be monitored usually without the consent of the person whose communication is monitored.

Procedure:

- Authorities make a request to the service provider, which is bound by law to record the conversations on the given number and provide these in real time through a connected computer.
- All interception of phones and emails by the Union home secretary or state home secretary follow the prescribed procedure.
- In unavoidable circumstances, such an order may be issued by an officer, not below the rank of a Joint Secretary to the Government of India, who has been authorised by the Union Home Secretary, or the State Home Secretary.
- In remote areas or for operational reasons, if it is not feasible to get prior directions, a call can be intercepted with the prior approval of the head or the second senior-most officer of the authorised law enforcement agency at the central level, and by authorised officers, not below the rank of Inspector General of Police, at the state level.

Power of tapping phones:

- In the states, police have the power to tap phones.
- At the Centre, 10 agencies are authorised to do so:
 - Intelligence Bureau,
 - CBI,

 - R&AW,
 Directorate of Signal Intelligence, and the Delhi Police Commissioner.
 Tapping by any other The competent authority must record reasons for tapping in writing.

Exception for the press:

Press messages intended to be published in India of correspondents accredited to the Central Government or a State Government shall not be intercepted or detained, unless their transmission has been prohibited under this subsection.

Data:

- On an average, 6,000 to 8,000 telephones are tapped by various agencies at any given time based on authorisation by the Union home secretary.
- Besides, around 10,000 more telephones are lawfully intercepted by state governments.

Issues with Phone Tapping

- Infringes right to privacy and liberty: The act of telephone tapping affects right to privacy as well as right to freedom of speech and expression, both are Fundamental Rights under the Constitution.
- Curtailment of freedom of speech: Violation of right of freedom of speech and expression is not permissible except what Article 19 of the Constitution provides.
- Constitutional Test: Not only substantive law but even the procedure should satisfy the constitutional test. The procedure should be just, fair and reasonable.

Existing Laws

- The Government follows procedures prescribed under the Indian Telegraph Act while ordering interception of phones and emails.
 - Section 5(2) says that "on the occurrence of any public emergency, or in the interest of the public safety", phone tapping can be done by the Centre or states if they are satisfied it is necessary with reasonable restrictions of:
 - In the interest of "public safety",



- Sovereignty and integrity of India,
- The security of the State, friendly relations with foreign States,
- Public order or
- For preventing incitement to the commission of an offence.
- Rule 419A of the Indian Telegraph (Amendment) Rules, 2007:
 - ➤ Phone tapping orders shall not be issued except:
 - By an order made by the Secretary to the Government of India in the Ministry of Home Affairs in the case of Government of India and
 - By the Secretary to the State Government in-charge of the Home Department in the case of a State Government.
- Besides this, an oversight committee which reviews each and every tapping ordered by the Union/state home secretary to verify if they were as per the law. The committee comprises the cabinet secretary (as head), law secretary and telecom secretary.

Measures Against Misuse

Using as Last Resort:

- > The law is clear that interception must be ordered only if there is no other way of getting the information.
- Rule 419A mentions that while issuing directions under sub-rule (1) the officer shall consider the possibility of acquiring the necessary information by other means and the directions under sub-rule (1) shall be issued only when it is not possible to acquire the information by any other reasonable means

Proper Reasons:

- Any order issued by the competent authority has to contain reasons, and a copy is to be forwarded to a review committee within seven working days.
- > At the Centre, the committee is headed by the Cabinet Secretary with the Law and Telecom Secretaries as members.
- In states, it is headed by the Chief Secretary with the Law and Home Secretaries as members.

Controlled Disclosure:

Directions for interception are to specify the name and designation of the officer or the authority to whom the intercepted call is to be disclosed, and also specify that the use of intercepted call shall be subject to provisions of Section 5(2) of the Telegraph Act. It is done to maintain transparency.

Limited Time Period:

The directions for interception remain in force, unless revoked earlier, for a period not exceeding 60 days. They may be renewed, but not beyond a total of 180 days.

Destruction of Records:

- Under the rules, records pertaining to such directions shall be destroyed every six months unless these are, or are likely to be, required for functional requirements.
- Service providers too are required to destroy records pertaining to directions for interception within two months of discontinuance of the interception.

Way Ahead

- Telephone-tapping infringes Article 21 of the Constitution of India unless it is permitted under the procedure established by law.
- Thus, the power of interception of communication can be resorted to, when it is necessary or expedient to do so in the interest of the sovereignty and integrity of India, security of the state, friendly relations with foreign states, public order or for preventing incitement to the commission of an offence.but Solomon Islands pijin is the lingua franca. There are over 80 different local languages plus dialects.

IMPORTANT FACTS FOR PRELIM

1. NASA's Perseverance Mission

Recently, the Perseverance Mars rover has captured Phobos, Mars' potato-shaped moon or satellite.

About

- The eclipse was captured with Perseverance's next-generation Mastcam-Z camera.
- These observations can help scientists better understand Phobos' orbit and how its gravity pulls on the Martian surface, ultimately shaping the red planet's crust and mantle
 - The last time NASA captured Phobos was in 2004, when the twin rovers 'Spirit' and 'Opportunity' took the first time-lapse photos of Phobos during a solar eclipse.
 - Curiosity, another NASA rover, also shot videos with its Mastcam camera system.



About Perseverance Mars Mission

- The Mars 2020 Perseverance mission is part of NASA's Moon to Mars exploration approach, which includes Artemis missions to the Moon that will help prepare for human exploration of the Red Planet.
- It addresses high-priority science goals for Mars exploration, including key questions about the potential for life on Mars.
- The mission takes the next step by not only seeking signs of habitable conditions on Mars in the ancient past, but also searching for signs of past microbial life itself.
- It introduces a drill that can collect core samples of the most promising rocks and soils and set them aside in a "cache" on the surface of Mars.

Opportunities

- The mission also provides opportunities to gather knowledge and demonstrate technologies that address the challenges of future human expeditions to Mars.
 - ➤ These include testing a method for producing oxygen from the Martian atmosphere, identifying other resources (such as subsurface water), improving landing techniques, and characterising weather, dust, and other potential environmental conditions that could affect future astronauts living and working on Mars.

Objectives

- Geology: Study the rocks and landscape at its landing site to reveal the region's history
- Astrobiology: Determine whether an area of interest was suitable for life, and look for signs of ancient life itself
- Sample Caching: Find and collect promising samples of Mars rock and soil that could be brought back to Earth in the future
- Prepare for Humans: Test technologies that would help sustain human presence on Mars someday.

2. Blue Straggler Stars

Recently, Scientists at Indian Institute of Astrophysics, Bengaluru, have found support for one way to understand peculiarity about Blue Straggler Star.

The researchers also made use of the observations by the UVIT instrument (UltraViolet Imaging Telescope) of ASTROSAT(India's first science observatory in space).

About Blue Straggler Stars

- They are a class of stars on open or globular clusters that stand out as they are bigger and bluer than the rest of the stars.
- They have intrigued scientists who have for long probed their origin.
- It is found in old star clusters and appears to be lagging behind most of the other stars in the cluster in its evolution toward a cooler, reddish state.
- Blue stragglers tend to be strongly concentrated toward the centre of the cluster.

Formation:

- A bunch of stars born at the same time from the same cloud form a star cluster.
- As time passes, each star evolves differently depending on its mass.
- The most massive and bright stars evolve and move off the main sequence creating a bend in their track, known as the turnoff.
- Stars above this bend or brighter and hotter stars are not expected in a cluster, as they leave the main sequence to become red giants.
- But in 1953, Allan Sandage found that some stars seem to be hotter than the turnoff of the parent cluster.
- Initially, these blue stars still straggling above the turnoff were not part of these clusters.
- However, later studies confirmed that these stars are indeed cluster members, and they were termed "Blue Stragglers".

About the Study

- They do not belong to the family of stars in the cluster, and hence are not expected to have the group properties.
- But if they actually belong to the group, the evasive behaviour is due to these stars gaining mass from a binary companion.
- The straggler draws matter from the giant companion star and grows more massive, hot and blue, and the red giant to end up as a normal or smaller white dwarf.
- The straggler draws matter from a companion star, but there is a third star that facilitates this process.
- The IIAP researchers have shown evidence that supports the second of the hypotheses listed above.



Relevance of the study

The study will help improve understanding of these stellar systems to uncover exciting results in studies of large stellar populations, including galaxies.
